Membership is £120 per club year (November 1st to October 31st). Membership can be paid in full by card or cheque or quarterly by a standing order of £30 (1st November, 1st February, 1st May and 1st August).

If joining part-way through the year you can pay the full amount due to the 31st October, including the month of joining; i.e. 15 July to October 31st = £40 (£10 per month). Or by standing order, the amount up to the next quarterly date and then quarterly from then.

## TERMS AND CONDITIONS

1. Andark Scuba Adventures is run and controlled by Andark Diving who have the control of all things related to the club including member benefits, discounts, events and boat operations
2. The 10% discount on courses is applicable through Andark only and on full price courses and cannot be used in conjunction with any other offer
3. All discounts and club benefits are for use by the club member only and will be monitored on the individuals members profile
4. 15% retail discount is available in the Andark shop only (excluding sale/discounted items, dive packs, books, weights and cylinders)
5. 1/2 price air fills can only be used by the club member at Andark. This is not valid at any other dive centre and has no monetary value
6. Any member abusing the benefits, discounts and membership will have their membership put on review and in cases of repeated misuse membership will be removed
7. The club boat is for use of club members only until such a time that a commercial endorsement can be held
8. The repair/replacement of damaged or lost equipment must be met by the member. Andark cannot be held liable for any damage or loss to members personal equipment
9. All boat/shore dives/trips and events must be paid for in full before the day. The aforementioned all require a minimum number to run
10. Every member must read, understand, sign and date a liability release form that will cover them for the year's diving, boat diving and Sunday dives
11. Every year, each member who does not have a diving medical signed by a physician, must complete a medical self-declaration to be held by Andark. If a medical is required by the diver, a copy must be held by Andark before any diving is allowed
12. I understand and agree that membership is yearly and runs from the 1<sup>st</sup> of November to the last day of October. I also understand that if I join at any time other than the 1st of November that I must pay the relevant fees up to the end of October, then from the 1st of November thereafter. I promise to pay the membership fee up to the and including October. If joining on the 1st of November I promise to pay for the whole year
13. If I stop payment part way through the year with out the prior agreement of Andark, Andark has the right to pursue those moneys still outstanding
14. I agree to pay the one of joining fee of £25 at the start of membership, unless I have been exempt by Andark
15. Andark reserves the right to cancel any event, dive or membership with out prior warning
16. Failure to attend a dive/trip/event on the date booked will result in the loss of all fees. No refunds of any monies paid will be given, save that Andark at its absolute discretion may offer a credit note redeemable at the Andark shop or against the cost of an alternative dive/trip/event. If you cancel a credit note will only be issued if your place can be resold and if the cancellation does not affect the minimum numbers needed to run.
